5. Court proceedings will not begin until 2 weeks after the date shown in paragraph 5. *[Provide further details to backup]*

Where the Landlord is seeking possession under the Housing Act, court proceedings cannot begin until 2 weeks after the date shown in paragraph 5.

After the date shown in paragraph 5, the Landlord must commence proceedings once but not later than 12 months after the date shown in paragraph 5. If the date shown in paragraph 5 has expired, this time the Notice will elapse and the Landlord must commence proceedings again. Possession can be sought.
